A I met him at the home of a friend of mine. That is, Dr. Gyssling is the German consul? A Yea. Q And you met him first at the home of Mrs. Ludington; is that correct? (Witness shakes head in the negative.) MR. RYON: I am afraid the reporter did not get the answer. The answer was "No". Q EY MR. ROGERS: At whose home? I would rather not say. 11 Q May I ask you to state the name? A Is it all right if I state it? MR. RYON: Yes. A Mrs. Philip Chanslor. Q BY MR. ROCERS: When was that? 16 A I think it must have been about March, 1940, -- about. 17 It was in the Spring. March of what year? 1940. Q 1940. That is this past March. You met him for the first time there? A Yes. Q Did you have any discussion with him at that time -any conversation with him? A Maturally. I had lunch with him and talked to him. Q Yes. At that time it was suggested that the Duke --

A They asked me to dothat, and I did.

And I asked for an aspirin tablet and they said they did not have any aspirin, but they were going to send out for it. And while I was waiting for it somebody said that brandy would relieve stomach cramps, so I took a glass of brandy and went back to the table. And our table was cutdoors where it was very cool, and I got a glass of brandy, a little glass about like that (indicating).

MR. AYON: The witness indicating about an inch and a quarter by her finger.
